## BOOKING PROCESS

1. Check availability with our Sales Department.
2. Fill in the Registration Form (hereinafter "RF") in clear writing and send it together with a proof of payment from your bank to [motogpvipvillage@dorna.com](mailto:motogpvipvillage@dorna.com).

All bookings are treated on a 'first come, first served' basis and subject to the MotoGP VIP Village™ Standard Terms and Conditions.

Same process is applied for both the MotoGP Lounge and Corporate Area. This RF is the only official order form, and can be requested to our Sales Department. It is the only valid document to make the reservation and the purchase of the passes.

The only accepted method of payment is via a bank transfer (bank details are on the RF).

Your passes are not officially reserved and processed until we have received both documents (RF and proof of payment).

Once we have received everything we will send you your passes by courier.

Invoices will be sent accordingly.

Applicable VAT subject to local legislation.

## SIGNAGE: IDENTIFICATION FOR PASSES AND CORPORATE AREAS

**MotoGP Lounge:** in the case of individuals a first name and surname only must be supplied. In case of Corporate order, signage must be the company's business or trade name. Corporate tables in the lounge can have logos and company names displayed.

**Corporate Area:** clients may have the logos printed on their passes and on their external signage.

Corporate Area clients must contact IES for extra services, setting up and dismantling policies.

## POLICIES

MotoGP VIP Village™ Passes are strictly personal and non-transferable. They must be worn at all times and in a visible manner. If the holder of a VIP Village Pass is found in a non-designated area, the pass will be confiscated immediately.

The MotoGP VIP Village™ Pass holder acknowledges that his presence in the different areas of the MotoGP VIP Village™ can be registered and be worldwide reproduced/or broadcasted, for any and all purposes, including commercial and promotional uses. As well The VIP Village Pass holder acknowledge that motorsport can be dangerous, releasing IES and any of its affiliated companies from any liability arising out from his presence in the MotoGP™.

- GOLD for Sunday
