## PURCHASE PROCESS

1. Check availability for VIP Passes with the Corporate Hospitality Sales Department.
  2. Fill in the **Registration Form (RF)** digitally or with clear handwriting.
  3. Send the **RF** together with the **proof of the bank transfer** by e-mail to your contact sales agent or to [motogpvipvillage@dorna.com](mailto:motogpvipvillage@dorna.com). The only accepted method of payment is through bank transfer (bank details are at the end of this document).
  4. Once IES has received everything correctly, the VIP passes corresponding to your purchase will be sent, along with the information necessary to access the event, approximately 2 weeks prior to the date of the Grand Prix. Preferably by DHL or alternative private courier and free of charge. Under no circumstances will the passes be sent without having received the relevant payment of such passes. The corresponding invoice will be sent by post and/or e-mail.
- This RF is the only official and valid document with which to carry out the booking and purchase process of VIP passes and can be requested from our Commercial Department. The reservation of the VIP passes related to your inquiry will not be confirmed until IES has received all the required documents (RF and proof of bank transfer).

## POLICIES

During their time in the MotoGP VIP Village<sup>™</sup>, the client shall always follow the instructions of the IES staff and likewise shall also comply with the protocols and security measures, including the COVID-19 prevention guidance that may be applicable. IES will duly inform the client of the applicable measures and they will be available and visible at the venue, as well as on the official MotoGP VIP Village<sup>™</sup> website, [www.motogpvipvillage.com](http://www.motogpvipvillage.com).

The VIP Passes give access to the spaces and services of the MotoGP VIP Village<sup>™</sup> and are strictly personal and non-transferable during the event. They must be always carried in a visible manner. If the holder of a MotoGP VIP Village<sup>™</sup> Pass is found in a non-designated area or in violation of applicable security rules or protocols, the pass will be immediately confiscated.

The MotoGP VIP Village<sup>™</sup> Pass holder acknowledges that their presence in the different areas of the MotoGP VIP Village<sup>™</sup> during their time at the event may be registered, reproduced and / or broadcast worldwide for many purposes, including commercial and promotional activities and use by IES. The holder of the MotoGP VIP Village<sup>™</sup> pass acknowledges that motorsports can be dangerous, thus releasing IES and any of its affiliated companies from any liability arising from their presence in MotoGP<sup>™</sup>.

## DRESS CODE

All clients must abide by MotoGP VIP Village<sup>™</sup> etiquette. The required dress code is Smart Casual. The use of tracksuits, beachwear and/or swimsuits, flip-flops, streetwear, tank tops or vests will not be allowed. Anything else related to the clients' dress code and the MotoGP VIP Village<sup>™</sup> label referred to in the Code of Conduct will be mandatory.

## FOOD ALLERGENS

## VIDEO/CAMERAS

Filming/recording is not permitted in the MotoGP VIP Village<sup>™</sup>, Pit Lane, Paddock, during the Service Road Tour or in any other access area allowed with the VIP Pass. If the client has access to MotoGP<sup>™</sup> content/images, their use is expressly prohibited.

## PARKING

The VIP Pass includes access to reserved parking per the corresponding ratio and according the type of purchase. Parking spaces are limited. IES reserves the right to alter this ratio or issue additional Parking Passes and, if so, charge an additional fee and/or impose special conditions, as necessary.

- **One Car Parking Pass** (vehicles up to 9 seats). The standard ratio is a 1 Parking Pass per day for every 4 guests.
- **Parking Bus Pass** (vehicles for more than 9 seats). Available on request and valid for both days (Saturday and Sunday).

## COVID-19 SPECIAL TERMS & CONDITIONS

1. **Cancellation of the Grand Prix by Dorna and / or the Governmental Authorities:**
  - 100% refund of the total amount paid for the VIP Pass.

2. **Suspension of the Corporate Hospitality Platform (MotoGP VIP Village<sup>™</sup>) but the Grand Prix takes place:**
  - 100% refund of the total amount paid for the VIP Pass.

3. **Cancellation by the client:**
